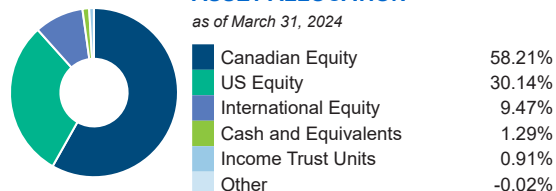

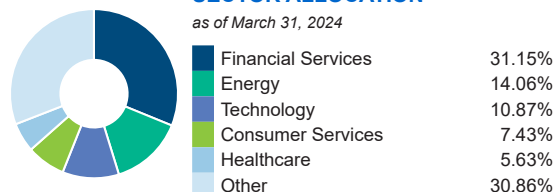
## ASSET ALLOCATION
