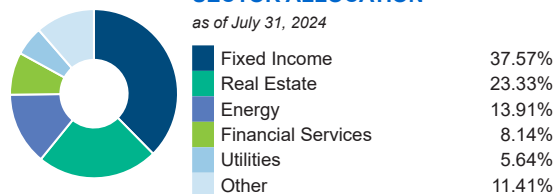
ASSET ALLOCATION

as of July 31, 2024



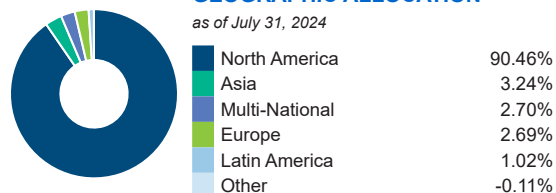
SECTOR ALLOCATION
