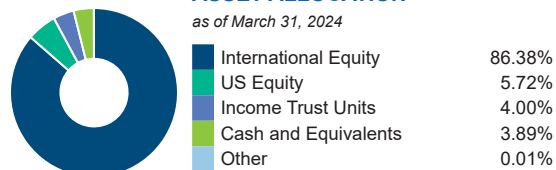

as of March 31, 2024



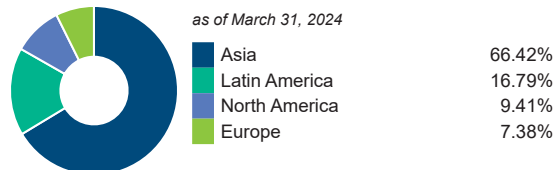
## SECTOR ALLOCATION
